#### Change Order No. 1

#### **Reason for Change**

This Change Order compensates the Contractor for lowering and encasing existing water service lines to the Williamson County Adult Probation Center and Parcel 41. The service lines will be lowered and encased 2 and ½ feet below finish grade of the ditches. This will allow for water service to be maintained across the proposed roadway, allows the lines to be removed if needed for any repairs and will not compromise the roadway structure if they do need future repairs.

Following is a summary of new items required for this Change Order.

This Change Order results in a net increase of \$29,260.00 to the Contract amount, for an adjusted Contract total of \$14,178,709.00. The original Contract amount was \$14,149,449.00. As a result of this and all Change Orders to-date, \$29,260.00 has been added to the Contract, resulting in an .21% net increase in the Contract cost. No additional days will be added to or deducted from the Contract as a result of this Change Order.
