THIS AMENDMENT NO. 1 to <u>Agreement for Planning, Design and Engineering Services</u> ("Amendment No.<u>1</u>") is by and between **Williamson County, Texas**, a political subdivision of the State of Texas ("County") and A/E.

RECITALS

WHEREAS, County and A/E previously executed that certain First Amended and Restated Agreement for Planning, Design and Engineering Services ("Agreement") being dated effective August 31st, 2023, wherein A/E agreed to perform certain professional planning, design and engineering services in connection with the Project;

WHEREAS, pursuant to **Article 20**, the terms of the Agreement may be modified by a written, fully-executed Contract Amendment;

WHEREAS, the parties wish to amend the Fee Schedule under **Exhibit B** and the Production Schedule under **Exhibit C** of the Agreement to reduce the original scope of work based on the lack of federal grant money; and,

WHEREAS, it has become necessary to supplement, modify and amend the Agreement in accordance with the provisions thereof.

NOW, THEREFORE, premises considered, County and A/E agree that the Agreement is supplemented, modified and amended as follows:
