**AMENDMENT TO  
PROFESSIONAL SERVICES AGREEMENT  
FOR DENTAL SERVICES AT THE WILLIAMSON COUNTY JAIL**

**THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT FOR DENTAL SERVICES AT THE WILLIAMSON COUNTY JAIL** (hereinafter "Amendment") is made and entered into by and between **Williamson County, Texas** ("County"), a political subdivision of the State of Texas, acting herein by and through its governing body, and **Todd C. Harris, P.C.** (hereinafter "Provider"), with offices at 1600 W. 38<sup>th</sup> St., Ste. 305, Austin, TX 78731. The parties originally entered into an Agreement on April 7, 2009, which has been previously amended and extended. Provider is engaged as an independent contract, to assist in providing certain operational services pursuant to the following terms, conditions, and restrictions:

**I.**

**Scope of Services:** This amendment will revise the number of hours per week for Provider to be physically present in the Jail infirmary to provide dental services. Provider agrees to be physically present for up to sixteen (16) hours per week during the term of this Agreement.

**II.**

**Cost and Payment:** This amendment will revise the compensation cap set forth in the original agreement (under paragraph III) to a monthly amount of fourteen thousand and forty-one dollars and sixty-six cents (\$14,041.66) and a yearly not-to-exceed amount for fiscal year 2025 (October 1, 2024 to September 30, 2025) of one hundred and sixty-eight thousand five hundred and zero cents (\$168,500.00).

**III.**

In all other respects, the Agreement is reaffirmed.
