


	<p>information as I could, he would not allow me to enter the mobile home to inspect of take pictures, he signed the Certificate of eligibility but his live in girlfriend was not available to sign he did say she was a US citizen; I will obtain a CE from her.</p> <p>I explained his eligible moving expenses and rent supplement.</p>
	<p>I explained that because the owner of the property was the Estate that he would be treated as a tenant and be eligible for tenant relocation benefits. Because he does not pay rent, I explained that I would have to calculate a Fair Market Rent for his current rent, I also requested his and his girlfriend income ,so that cold be used as part of his rent supplement calculation. I also explained that if he did not provide me all the household income that I could not use income calculations in the supplement. Mr. Stifflemire sent me email on May 3, 2024 stating that he did not want to provide income information.</p>

05-24-24	90-day letter sent certified mail and copy sent by email
05-31-24	Call from Brandi Mendiola asking about rent supplement for Blake I explained the supplement and how it was determined. I also ask about move estimates she said she would send them.
06-10-24	Brandi emailed move estimates.
06-17-24	Sent Brandi email explaining the supplement calculations.
06-25-24	Emailed Brandi an explanation of what was needed for the estimates and that they needed to be approved before move.
06-29-24	Sent Blak a text asking to meet to go over the estimates and take additional pictures inside the Mobile Home. Sam Nassour and myself met with Blake Stifflemire at the parcel. I went over the move options with him he has 2 movers that will be moving the items inside the MH and another to move the cars. Because the mover is unable to move all the personal property, he will do a self-move those items not moved by the movers. I explained that I needed approval for each of the moves and his move before he starts any move. I took additional pictures
07-11-24	Sent Blake an email asking him to confirm who was moving what property and explained again what relocation benefits he was entitled to and what I needed.
07-18-24	Sent Blake, Sam and Kathy Canady text asking Blake if he received my email from 7-11-24 and went over again what I needed, he did not reply
08-08-24	Sent 30-day letter
08-14-24	Spoke with Lonestar moving and Liberty Hill moving and explained direct payment by County and sent them forms for signature. Lonestar moving returned DPV forma and W-9 they will be moving items on Saturday 8-17-24.
08-19-24	I inspected MH and items have been moved. Prepared move claim for Lonestar moving and sent to Stifflemire for signature, claim was returned and prepared claim package to be sent to S&C for approval and payment.
