WHEREAS, the parties wish to amend the language relating to Contract Time under Article 3 of the Agreement; and,

WHEREAS, it has become necessary to supplement, modify and amend the Contract in accordance with the provisions thereof.

NOW, **THEREFORE**, premises considered, County and GC agree that the Contract is supplemented, modified and amended as follows:

I. Amendment to Article 3 – Contract Time

Article 3.1 – Contract Time shall be amended and supplanted by the following:

County shall provide a Notice to Proceed in which a date for commencement of the work shall be stated. GC shall achieve Substantial Completion within three-hundred ninety-one (391) calendar days after such commencement date. As such completion date may be extended by approved Change Orders. Unless otherwise specified in writing, GC shall achieve Final Completion within thirty (30) calendar days of Substantial Completion. The time set forth for completion of the work is an essential element of the Contract.

II. Terms of Agreement Control and Extent of Amendment No. #1

All other terms of the Contract and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.
