



PETPOINT ADDENDUM – MOBILE CHECKOUT

This PetPoint Addendum (this “Addendum”) to the PetPoint Application Service Provider Agreement dated effective on January 10, 2023 is made and entered into effective as the last party’s execution below (the “Addendum Effective Date”) by and between

Pethealth Services (USA) LLC

The State of Texas

 (“Client”)

herein referred to individually as “Party”, and jointly as “Parties”.

WHEREAS, PetPlace provides a cloud based data management software solution, known as PetPoint (“PetPoint”).

AND WHEREAS, PetPlace and Client have previously entered into a PetPoint Service Agreement (the “Agreement”) whereby PetPlace provides PetPoint to the Client;

AND WHEREAS, Client desires to utilize the latest version of the Mobile Checkout feature within PetPoint to facilitate the adoption process, and provide the adopter with a pet insurance quote opportunity;

NOW, THEREFORE, the Parties hereby agree as follows:

1. Mobile Checkout

1.1. Description. “Updated Mobile Checkout” is a feature within PetPoint, which provides a convenient solution for the adoption process by allowing the following functionalities:

- Capturing electronic signature(s) for contracts and other documents;
- Mobile credit card payments for adoption and shelter fees (optional);
- Mobile credit card payments for insurance purchases (required);
- Providing instant pet insurance quotes for adopters, from one or more of PetPlace’s affiliates that offer pet insurance (each a “Pet Insurance Affiliate”), with the capability for the adopter to purchase the quoted pet insurance.

1.2. Use of Updated Mobile Checkout. Client agrees to use the Updated Mobile Checkout feature in PetPoint for the adoption and checkout process, as outlined in this Addendum.

2. Obligation to Use Mobile Checkout

Client agrees to utilize the Updated Mobile Checkout feature for a minimum of 95% of all dog and cat adoptions. This usage shall include, but is not limited to, electronic signature capture, and insurance policy quotes from a Pet Insurance Affiliate.

3. Term

This Addendum shall commence on the Addendum Effective Date and shall continue in full force and effect until terminated by either Party in accordance with the termination provisions set forth in the Agreement.

4. Entire Agreement. This Addendum, together with the Agreement, constitutes the entire understanding between the Parties. With respect to the subject matter hereof, this Addendum supersedes any and all prior agreements or understandings, oral or written, with regards to Updated Mobile Checkout.

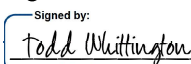
