### TO WORK AUTHORIZATION NO. 02

### WILLIAMSON COUNTY CORRIDOR PROJECT: SEWARD JUNCTION LOOP NORTH

This Supplemental Work Authorization No. <u>01</u> to Work Authorization No. <u>02</u> is made pursuant to the terms and conditions of the Williamson County Contract for Surveying Services, being dated <u>May 9, 2024</u> ("Contract") and entered into by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and <u>McGrav & McGrav Land Surveyors, Inc.</u> (the "Surveyor").

WHEREAS, the County and the Surveyor executed Work Authorization No. <u>02</u> dated effective <u>January 8, 2025</u> (the "Work Authorization");

WHEREAS, pursuant to Article 14 of the Contract, amendments, changes and modifications to a fully executed Work Authorization shall be made in the form of a Supplemental Work Authorization; and

WHEREAS, it has become necessary to amend, change and modify the Work Authorization.

#### **AGREEMENT**

NOW, THEREFORE, premises considered, the County and the Surveyor agree that the Work Authorization shall be amended, changed and modified as follows:

- I. The Service to be Provided by the Surveyor that were set out in the original Attachment "B" of the Work Authorization are hereby amended, changed, and modified to update existing design and topo survey limits (for 102,000 linear feet), to account for and locate new walls, fences, drainage features, utilities, signage, driveways, and intersections. All changes and reductions to services provided will be shown in the revised Attachment "B" (must be attached).
- II. The Work Authorization shall terminate on <u>September 30, 2025</u>. The Services to be Provided by the Surveyor shall be fully completed on or before said date unless extended by an additional Supplemental Work Authorization. The updated Work Schedule is attached hereto as Attachment "C" (must be attached).
- III. The maximum amount payable for service under the Work Authorization is hereby increased by \$21,401.80 from \$127,372.69 to \$148,774.49. The revised Fee Schedule is attached hereto as Attachment "D" (must be attached).

Except as otherwise amended by prior or future Supplemental Work Authorizations, all other terms of the Work Authorization are unchanged and will remain in full force and effect.

This Supplemental Work Authorization does not waive the parties' responsibilities and obligations provided under the Contract.
