A RESOLUTION COMMITTING TO A GOAL OF ZERO ROADWAY FATALITIES AND AUTHORIZING APPLICATION FOR THE SAFE STREETS AND ROADS FOR ALL (SS4A) GRANT.

WHEREAS, Williamson County, Texas recognizes that traffic fatalities and serious injuries are preventable, and that loss of life is unacceptable on our roadways; and

WHEREAS, the U.S. Department of Transportation "Safe Streets and Roads for All (SS4A) Program" supports implementation of local initiatives aimed at reducing and eliminating roadway fatalities and serious injuries for all roadway users through strategies identified in a comprehensive action plan using National Roadway Safety Strategy; and

WHEREAS, Williamson County, Texas and regional partners participated in safety planning activities to develop the "Williamson County Safety Action Plan" by identifying high-risk areas, analyzing crash data, engaging stakeholders, and outlining strategies to enhance transportation safety through the Safe System Approach; and

WHEREAS, Williamson County and the Capital Area Metropolitan Planning Organization (CAMPO) have a complex transportation system and traffic crashes remain a primary public safety issue in Williamson County with the Texas Department of Transportation reporting 9,795 vehicle crashes in the county, resulting in 22 fatalities in 2024; and

WHEREAS, the SS4A Implementation Grant provides an opportunity to obtain federal funding to support the design and construction of transportation safety projects to prevent crashes and minimize the harm caused to those involved; and

NOW THEREFORE BE IT RESOLVED that the Williamson County Commissioners Court commits to the vision of zero roadway fatalities and serious injuries by the year 2050, aligning with the objectives of the SS4A program and Texas Road to Zero;

FURTHER RESOLVED, that Williamson County hereby adopts the Williamson County Safety Action Plan, intends to implement projects, strategies, and policies from the plan, and will monitor and periodically report on progress toward the Road to Zero goal.
