## SUPPLEMENTAL WORK AUTHORIZATION NO. 2 TO WORK AUTHORIZATION NO. 1

### WILLIAMSON COUNTY ROAD BOND PROJECT: Engineering for SaltLake, Brook, and Front Street Project

This Supplemental Work Authorization No. 2 to Work Authorization No. 1 is made pursuant to the terms and conditions of the Williamson County Contract for Engineering Services, being dated March 19, 2024 and Contract Amendment No. 1, being dated April 9, 2025 ("Contract") and entered into by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and IEA, Inc. (the "Engineer").

WHEREAS, the County and the Engineer executed Work Authorization No.  $\underline{1}$  dated effective April 15, 2024 (the "Work Authorization");

WHEREAS, the County and the Engineering executed Supplemental Work Authorization No. 1 dated effective <u>April 16</u>, 2025 (the Supplemental Work Authorization No. 1);

WHEREAS, pursuant to Article 14 of the Contract, amendments, changes and modifications to a fully executed Work Authorization shall be made in the form of a Supplemental Work Authorization; and

WHEREAS, it has become necessary to amend, change and modify the Work Authorization.

#### **AGREEMENT**

NOW, THEREFORE, premises considered, the County and the Engineer agree that the Work Authorization shall be amended, changed and modified as follows:

- I. The Services to be Provided by the Engineer that were set out in the original Attachment "B" of the Work Authorization and the Supplemental Work Authorization No. 1 are hereby supplemented and modified as shown in the attached revised Attachment "B".
- II. The Work Authorization shall terminate on <u>December 31, 2025</u>. The Services to be Provided by the Engineer shall be fully completed on or before said date unless extended by an additional Supplemental Work Authorization. The revised Work Schedule is attached hereto as Attachment "C".
- III. The maximum amount payable for services under the Work Authorization and the Supplemental Work Authorization No. 1 is hereby increased from \$573,010.28 to \$675,995.90. The revised Fee Schedule is attached hereto as Attachment "D".

Except as otherwise amended by prior or future Supplemental Work Authorizations, all other terms of the Work Authorization are unchanged and will remain in full force and effect.

This Supplemental Work Authorization does not waive the parties' responsibilities and obligations provided under the Contract.




