This Work Authorization is made pursuant to the terms and conditions of the Williamson County Contract for Engineering Services, being dated <u>April 16, 2025</u> and entered into by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and American Structurepoint, Inc. - Part 5. This Work Authorization does not waive the parties' responsibilities and obligations provided under the Contract.
- Part 6. County believes it has sufficient funds currently available and authorized for expenditure to finance the costs of this Work Authorization. Engineer understands and agrees that County's payment of amounts under this Work Authorization is contingent on the County receiving appropriations or other expenditure authority sufficient to allow the County, in the exercise of reasonable administrative discretion, to continue to make payments under this Contract. It is further understood and agreed by Engineer that County shall have the right to terminate this Contract at the end of any County fiscal year if the governing body of County does not appropriate sufficient funds as determined by County's budget for the fiscal year in question. County may effect such termination by giving written notice of termination to Engineer.

ATTACHMENT A SERVICES TO BE PROVIDED BY THE COUNTY WILCO WAY (FORMERLY TRACY CHAMBERS LANE)

In addition to the services listed in the Agreement, the County will provide the following services:

- Furnish a Project Manager (GEC) to coordinate all aspects of the Project as needed with internal County staff
- Provide timely review and processing of monthly invoice submissions
- Timely approval or rejection of any or all work performed under this contract
- Provide timely reviews of recommendations offered by the Engineer and of deliverables including working documents, reports and drawings, in accordance with Attachment C, "Work Schedule" of the Work Authorization and comments / decisions necessary for the Engineer to maintain the project work schedule
- Furnish examples of acceptable format for the deliverables required by the work authorizations
- Furnish all known reference documents, information, and project data for the development of the project
- Provide available interface data for any projects adjacent to the project corridor
- Provide assistance as necessary in obtaining data and information from other local, regional, state, and federal agencies
- Furnish current version of all County's guidelines for preparation of environmental documents, air quality analysis, and noise analysis and versions of "recommended text" for air, noise, or other studies for which the County desires standard wording to be used

ATTACHMENT B SERVICES TO BE PROVIDED BY THE ENGINEER CONSTRUCTION PHASE SERVICES FOR WILCO WAY (FORMERLY TRACY CHAMBERS LANE)

PROJECT DESCRIPTION

Existing Facility

The existing Tracy Chambers Lane is 2-lane divided asphalt road with curb and gutter. The eastbound lane is approximately 20' face to face and the westbound lane is approximately 24' face to face. Tracy Chambers Lane eastern edge is 40' wide edge to edge with curb and gutter on 1 side and ribbon curb on the other. Drainage is conveyed through curb cuts on existing Tracy Chambers Lane into roadside ditches and grate inlets and by roadside on existing Wilco Way. The roadways are within Williamson County property.

Proposed Facility

The proposed project will connect existing Tracy Chambers Lane to Wilco way as well as reconstruct the existing Tracy Chambers Lane. The new road will be a 31' wide edge to edge 2-lane asphalt roadway with ribbon curb or curb and gutter. The reconstruction of existing Tracy Chambers will consist of the reconstruction and widening of the westbound lane and removal of the eastbound lane.

1. PROJECT MANAGEMENT

- a. MONTHLY PROGRESS REPORTS, INVOICES, AND BILLINGS:
 - Submit monthly progress status reports to the GEC. Progress reports will
 include: tasks completed, tasks/objectives that are planned for the
 upcoming periods, lists or descriptions of items or decisions needed from
 the County and its representatives. Subconsultant progress will be
 incorporated into the monthly progress report. A copy of the monthly
 progress report will be uploaded to ProjectWise.
 - Prepare correspondence, invoices, and progress reports on a monthly basis in accordance with current County requirements.

2. CONSTRUCTION PHASE SERVICES

a. REQUESTS FOR INFORMATION - RFIs (4 assumed):

- Attend site visits and/or meetings to gather data and information for RFI responses.
- Respond to Contractor RFIs and provide design clarifications, additional information, and additional data to the GEC as required within seven (7) calendar days.

b. REVIEW CONTRACTOR SUBMITTALS & SHOP DRAWINGS (2 assumed):

Review Contractor submittals and shop drawings received from the GEC.
 Shop drawings will be reviewed for general conformance with the plans and specifications and will include providing stamped concurrence, exceptions or resubmittal notations to the Contractor within seven (7) calendar days. The County will not be billed for plan revisions resulting from engineering errors or omissions.

c. PLAN REVISIONS FOR FIELD CHANGES (10 sheets assumed):

 Engineer will provide minor revisions to plans in order to address differing site conditions, third party accommodation, or other owner directed changes. Revisions to plans will include revision clouds around any changes, will include descriptions and quantities of changes, CAD files, and will be sealed by a professional engineer.

d. ATTEND MEETINGS (4 assumed):

- Engineer will attend meetings at the project site or Williamson County representative office, as requested. When in attendance, Engineer will provide meeting minutes and sign in sheet.
- Visit the project site on request (1 hour per visit) during construction to address questions on interpretation of plans.

3. DELIVERABLES

a. All contract documents, including hard copies and electronic files, shall be turned over to the County at each milestone and at the completion of the project. Documents shall be posted to the County's project management database as requested.

4. POST CONSTRUCTION LOMR

- a. The engineer will submit a post construction LOMR to meet City of Georgetown floodplain administrative requirements. A LOMR will be submitted for the Smith Branch Tributary through the entire WILCO JJC site. This will include up to two rounds of review comments with FEMA.
