

Amendment No. 4 to Jail Inmate Food Service Contract

THIS AMENDMENT NO. 4 (the “**Amendment**”), is entered into this [redacted] day of September, 2025 by and between Williamson County, TX (the “**County**”), and **Aramark Correctional Services, LLC**, a Delaware limited liability company, having its principal place of business located at 2400 Market Street, Philadelphia PA, 19103 (“**Aramark**”).

WHEREAS, the County and Aramark entered into a Jail Inmate Food Service Contract on November 23, 2021 for the management of the food service operation at the Williamson County Jail (as amended, the “**Agreement**”);

WHEREAS, the parties acknowledge the need to address volatility in the cost of food commodities; and


WHEREAS, the parties desire to amend the provisions of the Agreement as follows, effective November 23, 2025.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below. Capitalized terms used but not defined in this Amendment have the meanings ascribed to such terms in the Agreement.

1. **Price Adjustment:** In accordance with Section 6 of the Agreement, the parties agree that the price per meal charged to the County by Aramark shall be changed as set forth on Attachment A hereto as a result of changes in the Consumer Price Index. These prices shall be effective from November 23, 2025 through November 22, 2026, and shall supersede in all respects the price per meal set forth in Section 6 of the Agreement or in any other prior agreements between the parties.
2. **Ratification:** Except as specifically set forth herein, all other terms and provisions of the Agreement shall remain unaffected by this Amendment and continue in full force and effect
