

AGREEMENT NO. _____

This Amendment ("Fourth Amendment") is made and entered into as of the last date signed below herein by and between the County of Yolo, a political subdivision of the State of California ("County") and CommuniCare Health Centers, Inc. authorized to do business in the State of California ("Contractor") to amend Agreement No. 14-78 as stated below.

RECITALS:

WHEREAS, on or about May 27, 2014, the parties entered into Agreement No. 14-78 (the "Agreement"); and

WHEREAS, on or about January 21, 2015, the parties amended the Agreement (Amendment #1 of the Agreement); and

WHEREAS, on or about March 2, 2016, the parties amended the Agreement (Amendment #2 of the Agreement); and

WHEREAS, on or about October 25, 2016, the parties amended the Agreement (Amendment #3 of the Agreement); and

WHEREAS, the parties would now like to amend the Agreement to:

Increase contract amount by \$46,086 for FY15-16 for a new contract maximum amount of \$1,734,486.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

AGREEMENT

1. Section **III, COMPENSATION AND PAYMENT TERMS**, paragraph **B**, is hereby amended to read as follows:

B. Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor shall be no greater than **ONE MILLION SEVEN HUNDRED THIRTY FOUR THOUSAND FOUR HUNDRED EIGHTY SIX DOLLARS (\$1,734,486)** payable as follows:

3. Except as specifically amended by this Fourth Amendment, the Agreement shall remain in full force and effect according to its terms.

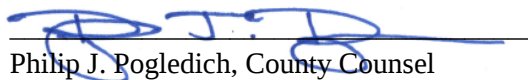
