

YOLO COUNTY AGREEMENT NO.

(Fourth Amendment to Agreement No. 2015-293 between the County of Yolo and Northern California Construction Training Regarding Pre-apprenticeship Construction Training at Yolo County Fairgrounds Services)

This Fourth Amendment to Agreement No. 2015-293 is entered into this 3rd day of March, 2018, by and between the County of Yolo, a political subdivision of the State of California, ("County"), and Northern California Construction Training ("NCCT" or "Contractor").

RECITALS

WHEREAS, on or about the 1st day of April, 2015, the parties entered into an agreement, Yolo County Probation No. 2015-293 ("Agreement"), for Contractor to provide certain Pre-Apprentice Construction Training relief services; and

WHEREAS, on or about the 1st day of July, 2016, the parties amended Agreement No. 2015-293, extending the term and adding additional funds for Pre-Apprentice Construction Training relief services; and

WHEREAS, on or about the 27th day of June, 2017, the parties amended Agreement No. 2015-293 by extending the term of the Agreement to March 31, 2018 and adding additional funds of Sixty Thousand Dollars (\$60,000) to the Agreement for Fiscal Year 2017-18; and

WHEREAS, the parties desire to amend the Agreement by changing extending the term of the Agreement to June 30, 2018 and adding additional funds of Twenty Thousand Dollars (\$20,000) to the Agreement for Fiscal Year 2017-18. This is necessary because County is releasing a request for proposals that will be financially supported by a partnership with Sacramento County Office of Education that requires any future term period of a vocation education service agreement to be calendared around a fiscal year, which the current Agreement as approved is not.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 2 of the Agreement is amended to read as follows:
 2. Contractor shall perform said services between April 1, 2015 and June 30, 2018.
2. Subject to Contractor's satisfactory fulfillment of the terms and conditions of this Agreement, and upon Contractor's submission of an appropriate claim or invoice, Agreement's total compensation shall be increased by \$20,000 for Fiscal Year 2017-18 and County shall pay Contractor a total amount not to exceed \$293,873 under the same monthly reimbursement terms originally budgeted as set forth here:

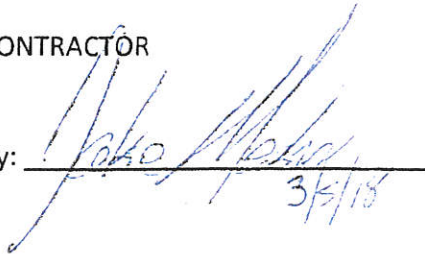

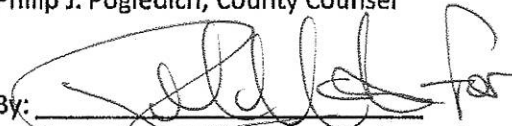
