

**SEVENTH AMENDMENT**  
(BOS Agreement No. \_\_\_\_ - \_\_\_\_)

This Seventh Amendment to Agreement PO No. 2247 (“Seventh Amendment”) is made and entered into as of the last date signed below herein by and between the County of Yolo, a political subdivision of the State of California (“County”), and Mental Health Management I, Inc., dba Canyon Manor, a corporation authorized to do business in the State of California (“Contractor”), herein referred to as the “Parties,” as stated below.

**WHEREAS**, on or about April 4, 2017, the Parties entered into Agreement PO No. 2247 (Agreement); and

**WHEREAS**, on or about February 6, 2018, the Parties amended the Agreement via the First Amendment; and

**WHEREAS**, on or about January 15, 2019, the Parties further amended the Agreement via the Second Amendment; and

**WHEREAS**, on or about April 19, 2019, the Parties further amended the Agreement via the Third Amendment; and

**WHEREAS**, on or about February 11, 2020, the Parties further amended the Agreement via the Fourth Amendment; and

**WHEREAS**, on or about June 16, 2020 the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

**WHEREAS**, on or about June 23, 2020 the Parties further amended the Agreement via the Fifth Amendment; and

**WHEREAS**, on or about September 1, 2020 the Parties further amended the Agreement via the Sixth Amendment; and

**WHEREAS**, the Parties would now like to amend the Agreement, as previously amended, to revise **Paragraph III.B1.** to add funding in the amount of \$102,000 for Fiscal Year (FY) 2020-21 for a new contract maximum of \$2,862,000; and

**NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:**

1. **Paragraph III.B1.** of the Agreement is hereby amended to read as follows:

**B1.** Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **June 30, 2021** shall be no greater than **TWO MILLION EIGHT HUNDRED SIXTY-TWO THOUSAND DOLLARS (\$2,862,000)** specified as follows:

2. Except as specifically amended by this Seventh Amendment and any prior amendments, the Agreement shall remain in full force and effect according to its terms.




