This memo shall serve as Yolo County staff's recommendation to appoint Dr. James Barrett to the Yolo Habitat Conservancy Implementation Advisory Committee representing the unincorporated parts of Yolo County for a term ending September 14, 2023.

The Yolo Habitat Conservancy Implementation Advisory Committee advises the YHC Board of Directors on the development and management of the reserve system of public and private lands consistent with the biological goals and objectives in Yolo HCP/NCCP Chapter 6, Conservation Strategy.

Per Yolo Habitat Conservancy Board, Minute Order No 20-36, the Yolo Habitat Conservancy Board of Directors approves all appointments to the advisory committee with the exception of seats allocated to the member agencies. The six members of the advisory body representing the Yocha Dehe Wintun Nation and the five member agency jurisdictions may be filled directly without subsequent ratification or other action by the Board of Directors. Each of the five municipal jurisdictions must comply with requirements of the Maddy Act (Government Code section 54974) for unscheduled vacancies by posting a vacancy notice in the office of its clerk prior to any appointment.
