ORDINANCE NO. 1543

ORDINANCE OF THE YOLO COUNTY BOARD OF SUPERVISORS
REPEALING SECTION 8-2.116 (MEDICAL MARIJUANA DISPENSARIES, PROHIBITED)
OF ARTICLE 1 (GENERAL PROVISIONS) AND
AMENDING SECTION 8-2.217(USE PERMITS)
OF ARTICLE 2 (ADMINISTRATIVE PROVISIONS)
OF CHAPTER 2 (ZONING REGULATIONS)
OF TITLE 8 (LAND DEVELOPMENT AND ZONING)
OF THE YOLO COUNTY CODE

The Board of Supervisors, of the County of Yolo, State of California, **DOES HEREBY ORDAIN** as follows:

Section 1. Purpose

The purpose of this ordinance is to: 1) repeal Section 8-2.116 of the Zoning Regulations prohibiting medical marijuana dispensaries; and 2) amend Section 8-2.217, Use Permits, of the Zoning Regulations to clarify and expand the process for revocation or modification of a use permit.

Section 2. Amendment of County Code

Section 8-2.116, Medical Marijuana Dispensaries, Prohibited is hereby repealed:

~~Sec. 8-2.116. Medical marijuana dispensaries, prohibited.~~

~~Medical marijuana dispensaries are prohibited in all zoning districts, including without limitation to all specific plan and overlay zones.~~

Section 8-2.217, Use Permits of Article 2, Administrative Provisions of Chapter 2, Zoning Regulations, of Title 8, Land Development and Zoning Section is hereby amended as shown in Exhibit 1.

Section 3. Severability

If any section, subsection, sentence clause, or phrase of this Ordinance or any exhibit is held by a court of competent jurisdiction to be invalid, such decision shall not affect the remaining portions of this Ordinance. The Board of Supervisors hereby declares that it would have passed this Ordinance, and each section, subsection, sentence, clause, and phrase hereof, irrespective of the fact that one or more sections, subsections, sentences, clauses, and phrases be declared invalid.

Section 4. Waiver of First Reading

This Ordinance shall be introduced by title and number only and the first reading waived.

Section 5. Effective Date and Publication

This Ordinance shall take effect and be in force thirty (30) days after its passage, and prior to expiration of fifteen (15) days after its passage thereof, shall be published by title and summary only in the Davis Enterprise together with the names of members of the Board of Supervisors voting for and against the same.

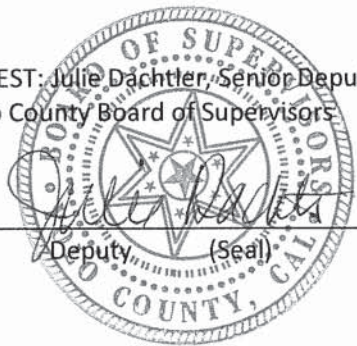
