

**EIGHTH AMENDMENT**  
(BOS No. \_\_\_\_ - \_\_\_\_)

This Eighth Amendment to Agreement No. 17-29 (“Eighth Amendment”) is made and entered into as of the last date signed below herein by and between the County of Yolo, a political subdivision of the State of California (“County”) and North Valley Behavioral Health, LLC, a limited liability corporation authorized to do business in the State of California (“Contractor”), herein referred to as the “Parties,” as stated below.

**WHEREAS**, on or about February 21, 2017, the Parties entered into Agreement No. 17-29 (“Agreement”); and

**WHEREAS**, on or about September 1, 2017, the Parties amended the Agreement via the First Amendment; and

**WHEREAS**, on or about July 10, 2018, the Parties further amended the Agreement via the Second Amendment; and

**WHEREAS**, on or about September 11, 2018, the Parties further amended the Agreement via the Third Amendment; and

**WHEREAS**, on or about July 23, 2019, the Parties further amended the Agreement via the Fourth Amendment; and

**WHEREAS**, on or about June 23, 2020, the Parties further amended the Agreement via the Fifth Amendment; and

**WHEREAS**, on or about August 4, 2020, the Parties further amended the Agreement via the Sixth Amendment; and

**WHEREAS**, on or about November 30, 2020, the Parties further amended the Agreement via the Seventh Amendment; and

**WHEREAS**, the Parties would now like to amend the Agreement, as previously amended, to revise **Paragraph III.B.** to add funding in the amount of \$29,420 for Fiscal Year (FY) 2020-21 for a new contract maximum of \$6,851,150; and

**NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:**

1. **Paragraph III.B.** of the Agreement is hereby amended to read as follows:

**B.** Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **June 30, 2021** shall be no greater than **SIX MILLION EIGHT HUNDRED FIFTY-ONE THOUSAND ONE HUNDRED FIFTY DOLLARS (\$6,851,150)** specified as follows:


