RESOLUTION OF THE YOLO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE SUBMISSION OF A GRANT PROPOSAL TO THE CALIFORNIA STRATEGIC GROWTH COUNCIL'S SUSTAINABLE AGRICULTURAL LANDS CONSERVATION PROGRAM, ADMINISTERED BY THE CALIFORNIA DEPARTMENT OF CONSERVATION, FOR THE DUNNIGAN COMMUNITY PLAN.

WHEREAS, the Sustainable Agricultural Lands Conservation Program is a component of the Strategic Growth Council's Affordable Housing and Sustainability Program and is administered by the Department of Conservation (Department) in conjunction with the Natural Resources Agency; and

WHEREAS, the purposes of the Sustainable Agricultural Lands Conservation Program are to protect agricultural land to support infill and compact development and to further the purposes of AB 32 by avoiding increases in greenhouse gas emissions associated with the conversion of agricultural land to nonagricultural uses; and

WHEREAS, funds have been allocated to the Sustainable Agricultural Lands Conservation Program from the Greenhouse Gas Reduction Fund to accomplish the above purposes; and

WHEREAS, the Department of Conservation has established Guidelines to disburse said allocated funds via a competitive process, which Guidelines require a resolution certifying approval of the application before submission of said application to the State.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Yolo as follows:

SECTION 1. The Yolo County Department of Community Services is hereby authorized and directed to apply for and submit to the Department the Dunnigan Community Plan (Project) grant application for the amount of \$79,599.00, including the matching fund amount of \$8,112.00 provided from the Yolo County General Plan Recovery fund.

SECTION 2. In connection with the Sustainable Agricultural Lands Conservation Program planning grant, if the application is approved by the Department, the Director of the Yolo County Department of Community Services (Director) is authorized to enter into a grant agreement with the Department for the project and accept the terms and conditions if the project is awarded funding.

SECTION 3. The Yolo County Board of Supervisors certifies that the funds will be used to further California's Planning Priorities specified in Government Code Section 65041.1.

SECTION 4. The Director is authorized and directed to accept the award of grant funding and to, execute and submit all documents including, but not limited to applications, agreements, payment requests and so on, which may be necessary for development of the plan, if the Project is awarded funding.
