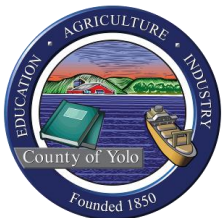

Dear County Clerk,

According to Elections Code §10515, if only one person applies as candidate for and elective office, *then "the board of supervisors of the county within which all or most of that division is located shall be the body to which request for appointment is made and which shall make the appointment."* Once appointed, the candidate shall assume office and serve exactly as if elected.

As the North Delta Water Agency (NDWA) Manager, I hereby certify that only one qualified landowner submitted a declaration of candidacy to fill the four- year term of Division 5 noticed for the 2021 NDWA District Election.

The majority of Division 5 is located in Yolo County. Therefore, the NDWA requests the Yolo County Board of Supervisors to appoint the unopposed incumbent Thomas Slater as Director of Division 5. Mr. Slater will subsequently serve the four-year term which is through December of 2025.
