Sustainability Coordinator (M: Management) Position: 2152	September 26, 2021	1.0	\$88,336 – \$107,380	Establishes a new class and salary range. Reallocates one (1) regular vacant full-time Senior Administrative Services Analyst placeholder position that was created at recommended budget to Sustainability Coordinator. This results in an annual fiscal impact of \$11,715.
County Administrator				
Natural Resources Planner (C2: Confidential- Professional) Position: PS-9005	September 26, 2021	2.0	\$86,182 – \$104,754	Establishes a new class and salary range. Reallocates one (1) regular full-time Associate Planner and one (1) regular full-time Natural Resources Program Coordinator to Natural Resources Planner. Reclassifies both incumbents as a result of position classification reviews conducted by Human Resources. This results in a salary increase of 5.5% and 12.2% for the incumbents respectively. This results in an annual fiscal impact of \$26,625.
Health and Human Services Agency				
Director of Public Health Nursing (X2: Unrepresented- Professional) Position: PS-13945	September 26, 2021	1.0	\$125,036 - \$151,982	Increases the salary range by 15.15% for Director of Public Health Nursing. Since the at-will position is currently vacant, there is no annual fiscal impact at this time.

Chief Mitigation Specialist (M: Management) Position: PS-20011	September 26, 2021	1.0	\$103,245 - \$125,495	Establishes a new class and salary range. Reallocates one (1) regular full-time Mitigation Specialist II position to Chief Mitigation Specialist. No incumbent reclassification is being requested at this time as the position will be filled following a competitive recruitment. This results in an annual fiscal impact of \$26,550.
Sheriff				
Deputy Coroner II (G: General) Position: 1989	September 26, 2021	1.0	\$68,761 - \$83,573	Extends one (1) limited-term vacant full-time Deputy Coroner II position for an additional two (2) years. This position will expire on January 5, 2024. This results in an annual fiscal impact of \$7,485.
