

EIGHTH AMENDMENT
(BOS Agreement No. ____ - ____)

This Eighth Amendment to Agreement PO No. 2247 (“Eighth Amendment”) is made and entered into as of the last date signed below by and between the County of Yolo, a political subdivision of the State of California (“County”), and Mental Health Management I, Inc., dba Canyon Manor, a corporation authorized to do business in the State of California (“Contractor”), referred to as the “Parties” herein and as stated below.

WHEREAS, on or about April 4, 2017, the Parties entered into Agreement PO No. 2247 (Agreement); and

WHEREAS, on or about February 6, 2018, the Parties amended the Agreement via the First Amendment; and

WHEREAS, on or about January 15, 2019, the Parties further amended the Agreement via the Second Amendment; and

WHEREAS, on or about April 19, 2019, the Parties further amended the Agreement via the Third Amendment; and

WHEREAS, on or about February 11, 2020, the Parties further amended the Agreement via the Fourth Amendment; and

WHEREAS, on or about June 16, 2020, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

WHEREAS, on or about June 23, 2020, the Parties further amended the Agreement via the Fifth Amendment; and

WHEREAS, on or about September 1, 2020, the Parties further amended the Agreement via the Sixth Amendment; and

WHEREAS, on or about August 31, 2021, the Parties further amended the Agreement via the Seventh Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to revise **Paragraph III.B1.** to add funding in the amount of \$5,510.25 for Fiscal Year (FY) 2020-21 for a new contract maximum of \$2,867,510.25; and

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

1. **Paragraph III.B1.** of the Agreement is hereby amended to read as follows:

B1. Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **June 30, 2021** shall be no greater than **TWO MILLION EIGHT HUNDRED SIXTY-SEVEN THOUSAND FIVE HUNDRED TEN DOLLARS AND TWENTY-FIVE CENTS (\$2,867,510.25)** specified as follows:


