Dear Ms. Dachtler:

I write this letter on behalf of Reclamation District No. 150 (the District) requesting that the County Board of Supervisors appoint three qualified persons to serve on the District Board of Trustees. The District published a Notice of Election Calling for Nominating Petitions in August 2021 to fill the expiring terms of Warren Bogle, Matthew Hemly, and Peter Anderson (interim replacement for Roger Berry). The only three candidates who indicated their intent to seek office were Mr. Bogle, Mr. Hemly, and Mr. Anderson. Mr. Berry is no longer trustee with the District following his stepping down from office in 2020. Accordingly, the District published a Notice of No Election on September 23, 2021.

Please arrange to have Mr. Bogle, Mr. Hemly, and Mr. Anderson appointed to serve 4-year terms. Enclosed for your records are Proofs of Publication of the Notice of Election Calling for Nominating Petitions and the Notice of No Election published by the District.
