### **Notice of Appointment of Board President and Trustee of Reclamation District 2035 Board of Trustees by Board of Supervisors in Lieu of Election**

California Water Code § 50740 and § 50742 states that when the number of nominees does not exceed the number of trustees to be elected to the Board of Trustees in a Reclamation District, the Board of Supervisors of the County in which the District is situated shall appoint to the position of trustees those persons nominated and no election shall be held. This notice is given pursuant to California Water Code § 50741 that one nomination was received for one trustee to be elected in Reclamation District 2035, and that the Board of Supervisors for Yolo County will appoint that Board President nominee, Kyriakos Tsakopoulos, and trustee nominee, Angelo Christie, to the Board of Trustees of Reclamation District No. 2035 at its next regular meeting.
