Technician Report:

System 1 was locked out on low pressure safety. I found small leak on the outside condenser coil and it is not repairable. I topped the unit off with 10lbs R-410A so it will work for now. The condenser coil will have to be replaced or the system will leak out again.

Pacific Mechanical Services Inc. will supply one York condenser coil for the 40 ton gym A/C unit. We will recover the old refrigerant so the coil can be removed and hauled away for proper disposal. Install one new condenser coil and evacuate the system to 500 microns. Charge the unit with R410A refrigerant to name plate specification. Turn the unit back on and check for proper operation.
