

YOLO COUNTY AGREEMENT NO. _____

(Second Amendment to Agreement No.16-87 with CommuniCare Health Centers, Inc, relating to Juvenile Justice Community Treatment Services, to increase the Maximum Compensation, and extend the Term)

THIS SECOND AMENDMENT to Agreement No. 16-87 is made and entered into as of this 7th day of December, 2021, by and between the County of Yolo, a political subdivision of the State of California (“County”), and CommuniCare Health Centers, a non-profit entity providing health services in Yolo County (“Contractor”), who agree as follows.

WHEREAS, on or about June 21, 2016, the parties entered into an agreement for Contractor to provide Juvenile Justice Community Treatment Services to the County (Yolo County Agreement No. 16-87); and

WHEREAS, the parties previously amended Agreement No. 16-87 to increase the maximum compensation and extend its term; and

WHEREAS, the parties wish to amend again Agreement No. 16-87 to increase the maximum compensation and extend its term.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

1. Paragraph **II.** of Agreement No. 16-87 is hereby amended to read as follows:

II. COMPENSATION AND REIMBURSEMENT OF EXPENSES

A. For the services described in Paragraph I above, and subject to the condition that the services have been completed in a manner satisfactory to the Director or his/her designee, Contractor shall be compensated as follows:

January 1, 2022-March 31, 2022: Forty-six thousand, seventy-five dollars (\$46,075)

Provided, however, that the total amount of compensation to be paid Contractor for the services required by this Agreement shall not exceed one-million, thirteen thousand, seventy-five dollars (\$1,013,075) for the original three contract years, the two additional year extension opportunity and this three-month amendment.

2. Section **VIII.** of Agreement No. 16-87, is hereby amended to read as follows:

VIII. TERM AND TERMINATION

A. The term of this Agreement shall be from July 1, 2016 through March 31, 2022, unless sooner terminated as hereinafter provided

3. Except as specifically amended by the First Amendment and herein, Agreement No. 16-87 shall remain in full force and effect according to its terms.
