**Resolution Authorizing Acceptance and Execution of 2022 Community Services Block Grant Agreement with the California Department of Community Services and Development**

**WHEREAS**, the County of Yolo (“County”) received notice from the California Department of Community Services and Development (“Department”) of the Department’s intention to enter into a Community Services Block Grant (“CSBG”) agreement with the County to provide services to low-income families and low-income individuals in the County with the goal of attaining skills, knowledge and motivations, and securing the opportunities needed to become fully self-sufficient; and

**WHEREAS**, on or about December 16, 2020, the County issued Resolution No. 20-136 authorizing acceptance of CSBG Agreement Number 21F-4052 (Yolo County Agreement No. 20-298) for funding in the amount of \$303,665 for the period of January 1, 2021 through May 31, 2022; and

**WHEREAS**, on or about October 26, 2021 the County issued Resolution No. 21-138 authorizing acceptance of CSBG Agreement Number 21F-4052 Amendment 2 any and all subsequent amendments and revisions thereto up to a funding total of \$350,000; and

**WHEREAS**, Department has now issued CSBG Agreement Number 22F-5052 for funding in the amount of \$302,667 for the period of January 1, 2022 through May 31, 2023; and

**WHEREAS**, it appears in the best interests of the County, its residents, and other customers to continue participation in the CSBG program.

**NOW, THEREFORE, BE IT RESOLVED THAT:**

1. County is hereby authorized and directed to accept this CSBG funding, including Agreement Number 22F-5052 and any and all subsequent amendments and revisions thereto (“Agreement”), up to a funding total of \$350,000.
2. The Chair of the Yolo County Board of Supervisors is approved to execute this Agreement, including associated attachments, exhibits, and forms.
3. The Procurement Manager, or designee, is authorized to enter into and accept any additional financial or nonfinancial amendments and revisions of the Agreement, including attachments, exhibits, and forms, up to a funding total of \$350,000, and upon approval as to form by County Counsel.
