

RESOLUTION NO. ___ - _____

A Resolution authorizing the Use of Fund Balance in the Amount of \$759,819 for the 2022 Primary Election and the Purchase a new Mobile Vote Center

WHEREAS, the Elections Office within the Assessor/Clerk-Recorder/Elections (“ACE”) Department is responsible for conducting all federal, state, county, school district, and special district general and special elections in Yolo County; and

WHEREAS, the Elections Office carries out its duties while adhering to strict guidelines set forth in Federal Law and the California Elections Codes; and

WHEREAS, in July 2021, the Yolo County Elections Office was issued \$1,729,200 in one-time and restricted funding for the 2021 California gubernatorial Recall Election, of which \$1,055,076 has been expended for this purpose; and

WHEREAS, during the Adopted Budget process, unallocated funds were set aside in the fund balance and, with clarification from the State, these funds are to be used on expenses incurred on the state portion of the June 7, 2022 Statewide Direct Primary Election to include Salaries and Benefits, Supplies and Services, and Equipment; and

WHEREAS, Yolo County is currently transitioning formally from the polling place model to the Voter's Choice Act (VCA) voting model or Vote Center type of voting; and

WHEREAS, the Yolo County Election Administration Plan (EAP) currently under review by the State includes a plan to reach out to voters in remote locations and to provide voting information services in all areas of the county, and the acquisition of a Mobile Vote Center, including a truck for towing purposes, will help accomplish this goal; and

WHEREAS, Sections 29125 and 29130 of the Government Code provide for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The foregoing recitals are true and correct.
2. The Chief Financial Officer is authorized and directed to amend the inventory list to include these vehicles for fiscal year 2021-22 and to adjust the department budget as follows:


