Dear Ms. Alves:

I am a Deputy County Counsel in the office of the Sacramento County Counsel, counsel to the Sacramento Regional County Sanitation District ("Regional San"), a county sanitation district organized and existing pursuant to the provisions of Chapter 3 of Part 3 of Division 5 (Sections 4700 et seq.) of the Health and Safety Code of the State of California.

I am writing to reconfirm Regional San's interest in acquiring the above-referenced parcel in Yolo County and to opine on the impact the acquisition will have on Regional San's sphere of influence.

In rendering this opinion, I have examined the Sacramento County Local Agency Formation Commission Resolution 362, dated Sept. 11, 1973, and subsequent additions to the sphere of influence to include the most current map of 2018. I have also reviewed the location of the above-referenced parcel. The subject parcel is a 5,000 sq. ft. triangle-shaped parcel located within the boundaries of Regional San's South River Sewage Pumping Station & Force Mains at 30030 South River Road, West Sacramento, CA 95691 and is surrounded on all sides by parcels owned by Regional San, APNs 044-020-004-000 and 004-020-034-000. It appears that a surveying error may have occurred and the parcel was not included in Regional San's adjoining parcels. Based on the foregoing, the acquisition of the subject parcel will not conflict with Regional San's sphere of influence parameters.
