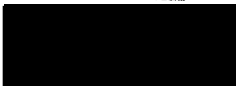

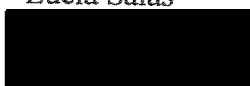
Dear Julie:

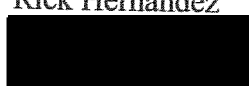
