**FIRST AMENDMENT  
 YOLO COUNTY AGREEMENT NO. SE 21-7**

This First Amendment to Agreement No. SE 21-7, PO 3879 (“First Amendment”) is made and entered into as of the last signature date set forth below between the County of Yolo, a political subdivision of the State of California, (“County”), and Yolo County Children’s Alliance (“Worksite”), collectively referred to as “the Parties” herein and who agree as follows:

**WHEREAS**, on or about January 12, 2021, the Parties entered into Agreement No. SE 21-7 (“Agreement”); and

**WHEREAS**, on or about May 27, 2021, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

**WHEREAS**, the Parties would now like to amend the Agreement to:

1. Revise **Section 3**. to increase the maximum cost to the County by \$32,604 for Fiscal Year (FY) 2021-22 and add funding in the amount of \$63,888 for (FY) 2022-23 for a new contract maximum of \$129,492; and
2. Revise **Section 4**. to extend the term of the agreement through June 30, 2023.

**NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:**

1. **Section 3** of the Agreement is hereby amended to read as follows:

**3. MAXIMUM COST TO THE COUNTY**

In no event will the cost to the County for the services provided under this Agreement exceed the maximum amount of **\$129,492**, including gross wages, overhead and administration costs, which include direct non-salary expense and Worker’s Compensation costs. Of that maximum amount payable, overhead and administration costs may not exceed **\$12,949.20**. The amount of this Agreement may be reviewed and increased with the written consent of County if placements warrant it.

2. **Section 4** of the Agreement is hereby amended to read as follows:

**4. TERM OF AGREEMENT:**

This Agreement shall commence on **December 4, 2020** and shall terminate on **June 30, 2023**. Certificate(s) of Insurance must be current on the day the Agreement commences and, if scheduled to lapse prior to termination date, must be updated before final payment will be made to Worksite. The final invoice must be submitted within 30 days of completion of the stated scope of services or expiration of this Agreement, whichever is sooner.

3. Except as specifically amended by this First Amendment, the Agreement shall remain in full force and effect according to its terms.
