(Resolution increasing the District Attorney’s budget in the amount of \$152,000 for procurement of NICE Justice Systems SaaS, using IT Innovation Contingency Funds.)

WHEREAS, the Yolo County District Attorney’s Office is responsible for the collection and discovery of digital evidence; and

WHEREAS, the current practices of evidence collection, evidence analysis, and evidence discovery to defense attorneys are very labor-intensive; and

WHEREAS, NICE Justice Systems is a comprehensive Software-as-a-Service cloud based solution that provides a digital evidence, digital discovery, and justice solution which helps District Attorney offices streamline digital discovery throughout the justice process from crime to court; and

WHEREAS, this system will help the Criminal Justice System in Yolo County become more efficient; and

WHEREAS, IT Innovation funds are available and have been authorized; and

WHEREAS, said funds were not included in the fiscal year 2021-2022 budget for the District Attorney’s Office; and

WHEREAS, Section 29125 of the Government Code provides for the transfer from appropriation for contingencies by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, BE IT RESOLVED as follows:

2. The Chief Financial Officer is authorized and directed to amend the budget for fiscal years 2021-2022 as follows:
