

**SECOND AMENDMENT
 (BOS AGREEMENT NO. ____ - ____)**

This Second Amendment to Agreement No. 21-174 (“Second Amendment”) is made and entered into as of the last date signed below by and between the County of Yolo, a political subdivision of the State of California (“County”), and Interfaith Rotating Winter Shelter, dba Heart of Davis, a corporation authorized to do business in the State of California (“Contractor”), jointly referred to as the “Parties” herein and who agree as follows.

WHEREAS, on or about July 27, 2021, the Parties entered into Agreement No.21-174 (“Agreement”); and

WHEREAS, on or about December 9, 2021, the Parties amended the Agreement via the First Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise the **SUBAWARD INFORMATION** to:
 - a. Update the Subaward Project Title to add the reference to Emergency Solutions Grant-Coronavirus Round 1 (ESG-CV Round 1) funding; and
 - b. add ESG-CV Round 1 funding in the amount of \$47,000 and reduce the ESG-CV Round 2 funding by \$376,566.79, for a new contract maximum of \$338,433.21; and
 - c. Revise the Project Period.
2. Revise **Paragraph X.A. of Attachment 6** to update the contract budget and revise the line item amounts ; and

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

1. The **SUBAWARD INFORMATION** of the Agreement is hereby amended to read as follows:
