Resolution Authorizing Acceptance of Title I Workforce Innovation and Opportunity Act Grant Agreement (Youth Programs) for FY2021-24 through the California Employment Development Department.

WHEREAS, the County of Yolo ("County") has been designated to receive a Workforce Innovation and Opportunity Act ("WIOA") Subgrant from the State of California Employment Development Department ("EDD") to continue to fund programs to provide employment and training services to Yolo County youth; and

WHEREAS, EDD has designated the agreement as Title I WIOA Subgrant No. AA311045 Youth Formula ("Agreement"); and

WHEREAS, the term of the Agreement is from April 1, 2022, to June 30, 2024 in the amount of \$656,451; and

WHEREAS, there are no matching funds requirements for this grant; and

WHEREAS, it appears to be in the best interest of the County, its residents, and its clients to enter into Agreement.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Each of the foregoing recitals is true and correct.
2. County is hereby authorized and directed to accept this WIOA Youth Formula funding under the Agreement and all subsequent amendments or revisions thereto.
3. The Chair of the Board of Supervisors is authorized to execute the Agreement to receive WIOA funds in the amount of \$656,451 for the period of April 1, 2022 through June 20, 2024.
4. County Procurement Manager, or designee, is authorized to act on behalf of County in connection with the Agreement and to enter into and accept any financial amendments and revisions to the Agreement that are consistent with current County Procurement Policy upon approval as to form by the County Counsel.
5. The Director of the Health and Human Services Agency ("HHSA"), or designee, is authorized to execute any non-financial extensions or amendments to the Agreement upon approval as to form by the County Counsel.
6. The Director of HHSA, or designee, is authorized to sign any WIOA fiscal and program reports required under the Agreement, including reports required under any extensions or amendments thereto.
7. County shall be subject to the terms and conditions specified in the Agreement, and County will use Agreement funds in accordance with applicable rules and laws and pursuant and subject to all of the terms and provisions applicable to WIOA agreements through the EDD.
