

YOLO COUNTY AGREEMENT NO. 22-_____

(Second Amendment to Agreement No. 19-161 with Lincoln Training Center and Rehabilitation Workshop, Inc. relating to Janitorial Services, to revise the Terms of Payment, increase the Maximum Compensation and extend the Term)

THIS Second Amendment to agreement No. xx-xx is made and entered into as of this 1st day of July, 2022, by and between the County of Yolo, a political subdivision of the State of California (“County”), and Lincoln Training Center and Rehabilitation Workshop Inc., a California 501(c)(3) corporation (“Contractor”), who agree as follows.

WHEREAS, on or about July 23, 2019, the parties entered into an agreement for Contractor to provide janitorial services to the County (Yolo County Agreement No. 19-161); and

WHEREAS, on or about November 5, 2019, the parties amended Agreement No. 19-161 (Agreement No. 19-254) to revise the Scope of Work and increase the maximum compensation; and

WHEREAS, the amount for additional janitorial services has exceeded the amount in Agreement No. 19-161 due to additional COVID cleaning protocols by \$355,070; and

WHEREAS, the parties wish to amend Agreement No. 19-161 to revise the Terms of Payment, extend the current contract Term for one additional year through June 30, 2023 with the option to renew the Agreement for up to two additional one-year terms, and to increase the maximum Compensation; and

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

1. Paragraphs III.A and III.B of Agreement No. 19-161 are hereby amended to read as follows:

III. COMPENSATION

A. For the services described in Paragraph I above (Basic Services), and subject to the condition that the services have been completed in a manner satisfactory to the Director or his/her designee, Contractor shall be compensated as follows:

August 1, 2019 through June 30, 2020: \$676,972.62
July 1, 2020 through June 30, 2021: \$830,577.12
July 1, 2021 through June 30, 2022: \$900,201.48
July 1, 2022 through June 30, 2023: \$1,071,960

Provided, however, that the total amount of compensation to be paid Contractor for the services required by this Agreement shall not exceed \$3,479,711.22 dollars. In the determination of hourly fees, time allotments shall be calculated to one-tenth of an hour.


B. For the services described in Paragraph II above (Additional Services), County shall compensate Contractor at the rates established in Exhibit D; provided, however, that the total amount of any such compensation shall not exceed an additional \$355,070 dollars above the

maximum amount in Paragraph III.A. In the determination of hourly fees, time allotments shall be calculated to one-tenth of an hour.

2. Exhibit E, attached hereto, is hereby added to the Agreement, and incorporated by reference to include new task sheets.
3. For purposes of clarity, the parties confirm that the Agreement is being extended for one additional year from July 1, 2022 through June 30, 2023 and that the County retains the option(s) to further extend the Agreement for up to two additional one-year periods pursuant to **Paragraph IX.B** of the Agreement.
4. Except as specifically amended hereinabove, Agreement No. 19-161 shall remain in full force and effect according to its terms.


