**SECOND AMENDMENT
YOLO COUNTY AGREEMENT NO. SE 21-7
(BOS AGREEMENT NO. ____ - ____)**

This Second Amendment to Agreement No. SE 21-7, also known as PO 3879 (“Second Amendment”), is made and entered into as of the last date signed below, by and between the County of Yolo, a political subdivision of the State of California (“County”), and Yolo County Children’s Alliance (“Worksite”), jointly referred to as “the Parties” herein and who agree as stated below.

WHEREAS, on or about January 12, 2021, the Parties entered into Agreement No. SE 21-7 (“Agreement”); and

WHEREAS, on or about May 27, 2021, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

WHEREAS, on or about May 10, 2022, the Parties amended the Agreement via the First Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended to:

- 1. Revise **Section 3.** to add funding in the amount of \$35,112 for (FY) 2022-23 for a new contract maximum of \$164,604.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

- 1. **Section 3.** of the Agreement is hereby amended to read as follows:

3. MAXIMUM COST TO THE COUNTY

In no event will the cost to the County for the services provided under this Agreement exceed the maximum amount of **\$164,604**, including gross wages, overhead and administration costs, which include direct non-salary expense and Worker’s Compensation costs. Of that maximum amount payable, overhead and administration costs may not exceed **\$16,460.40**. The amount of this Agreement may be reviewed and increased with the written cosent of County if placements warrant it.
