Auditor-Appraiser II (G: General) Position: PS-3210 January 15, 2023	1.0	\$64,892 - \$78,876	Reallocates one (1) regular vacant full-time position from Senior Assessment Technician to Auditor-Appraiser II. The annual fiscal impact is approximately \$14,054.	
Senior Assessment Technician (G: General) Position: PS-3210 January 15, 2023	0.0	\$53,984 - \$65,618	Abolishes the class of Senior Assessment Technician, which is no longer in use by the department. There are no positions or incumbents assigned to the class, which results in no fiscal impact.

Senior Accounting Technician - Confidential (C1: Confidential-Clerical) Position: 1744 January 15, 2023	1.0	\$58,448 - \$71,044	Increases the FTE from 0.5 to 1.0 for one (1) regular vacant full-time position. The annual fiscal impact is \$63,246 and will be funded by the General Fund.

Deputy District Attorney V (A2: Supervising Attorney) Position: PS-11540 July 3, 2022	1.0	\$167,472 - \$203,563	Reallocates one (1) regular full-time position from Deputy District Attorney IV to Deputy District Attorney V. This action was inadvertently left off at recommended budget. A departmental promotional recruitment was conducted to fill the position at this level. The annual fiscal impact is \$46,726.

Executive Assistant II (X3: Unrepresented Support) Position: PS-13111 January 15, 2023	1.0	\$71,228 - \$86,578	Reallocates one (1) full-time position from regular HHSA Analyst to At-will Executive Assistant II. Reclassifies the incumbent, resulting in a salary increase of approximately 4.8%. The annual fiscal impact is a savings of approximately \$11,670

Associate Administrative Services Analyst (G: General) Position: NEW January 15, 2023	1.0	\$66,678 - \$81,048	Adds one (1) new limited-term full-time position funded by the Public Defense Pilot Program, to include the implementation of the provisions of Penal Code 1473.7 that provide for resentencing if a conviction was "sought, obtained or imposed on the basis of race, ethnicity, or national origin". This position will expire March 1, 2023. The annual fiscal impact is \$129,537.
