Office Support Specialist (G: General) Position: PS-13012  February 26, 2023	1.0	\$46,426 - \$56,430	Reallocates one (1) regular vacant full-time position from Administrative Clerk II to Office Support Specialist in the Adult & Aging branch. The annual fiscal impact is \$7,405.
