SIXTH AMENDMENT

This Sixth Amendment to Agreement No. 18-223 (“Sixth Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo, a political subdivision of the State of California (“County”), and CommuniCare Health Centers, Inc., a non-profit corporation authorized to do business in the State of California (“Contractor”), jointly referred to as the “Parties” herein and who agree as stated below.

WHEREAS, on or about May 21, 2018, the County released a Request for Proposal (“May 2018 RFP”) seeking a qualified community-based a qualified community-based organization to provide CalWORKs mental health services and Contractor submitted a proposal; and

WHEREAS, on or about July 10, 2018 County posted an Intent to Award Letter for the May 2018 RFP naming Contractor; and

WHEREAS, on or about October 9, 2018, the Parties entered into Agreement No. 18-223 (“Agreement”); and

WHEREAS, on or about June 20, 2019, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1: and

WHEREAS, on or about June 18, 2020, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #2: and

WHEREAS, on or about December 18, 2020, the Parties amended the Agreement via the First Amendment; and

WHEREAS, on or about May 3, 2021, the then acting Procurement Manager determined it was in the best interest of the County to extend the contract award from the May 2018 RFP based on satisfactory service and reasonable prices and to avoid the interruption of County business, and thus approved a sole source letter to document this extension; and

WHEREAS, on or about June 8, 2021, the Parties further amended the Agreement via the Second Amendment; and

WHEREAS, on or about June 28, 2022, the Parties further amended the Agreement via the Third Amendment; and

WHEREAS, on or about November 3, 2022, the County a Request for Proposal (“November 2022 RFP”) seeking a qualified community-based a qualified community-based organization to provide CalWORKs mental health services; and

WHEREAS, on or about December 6, 2022, the Parties further amended the Agreement via the Fourth Amendment to extend the term through March 31, 2023 to allow time for the November 2022 RFP and resulting contract negotiations to conclude; and

WHEREAS, on or about March 7, 2023, the Parties further amended the Agreement via the Fifth Amendment; and

WHEREAS, on or about March 8, 2023, County posted an Intent to Award Letter for the November 2022 RFP naming Contractor; and

WHEREAS, to prevent a contract lapse and an interruption in services/disruption in the continuity of care for clients served under this program; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Paragraph I.A.** to extend the term of the Agreement through April 30, 2023; and
2. Revise **Paragraph III.B.** to add funding in the amount of \$31,536.67 for Fiscal Year (FY) 2022-23 for a new contract maximum of \$1,421,892.67; and
3. Revise **Exhibit E** to update the budget for FY 2022-23.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

1. **Paragraph I.A.** of the Agreement is hereby amended to read as follows:

- A. The term of this Agreement shall be from **October 1, 2018 through April 30, 2023** unless sooner terminated as provided in this Agreement.

2. **Paragraph III.B.** of the Agreement is hereby amended to read as follows:

III. COMPENSATION AND PAYMENT TERMS

- B. Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **April 30, 2023**, shall be no greater than **ONE MILLION FOUR HUNDRED TWENTY-ONE THOUSAND EIGHT HUNDRED NINETY-TWO DOLLARS AND SIXTY-SEVEN CENTS (\$1,421,892.67)** specified as follows:

Fiscal Year 2019-20 July 1, 2019 through June 30, 2020	\$289,301.00
Fiscal Year 2020-21 July 1, 2020 through June 30, 2021	\$309,627.00
Fiscal Year 2021-22 July 1, 2021 through June 30, 2022	\$309,627.00
Fiscal Year 2022-23 July 1, 2022 through April 30, 2023	\$301,536.67
Total	\$1,421,892.67

3. Any and all attachments to this Sixth Amendment are incorporated herein by this reference.

4. Except as specifically amended by this Sixth Amendment and any prior amendments, the Agreement shall remain in full force and effect according to its terms.






