Accounting Technician (G: General) Position(s): PS-1140, 2278 June 4, 2023	2.0	\$37,211 - \$45,219	Reallocates two (2) full-time positions from Office Support Specialist to Accounting Technician. Reclassifies both incumbents after a consultant review of the position, resulting in salary increases of 9.0% and 14.4% respectively. The annual fiscal impact is \$14,768.

Planning Manager (M: Management) Position(s): PS-7131 June 18, 2023	1.0	\$121,938 – \$148,217	Establishes new class and salary range. Reallocates one (1) regular full-time position from Principal Planner to Planning Manager. Reclassifies the incumbent, resulting in a salary increase of approximately 10%. The annual fiscal impact is \$13,475.	
County Service Area Manager (X2: Unrepresented- Professional) Position(s): 1725 June 18, 2023	1.0	\$92,480 - \$112,409	Establishes new class and salary range. Reallocates one (1) regular full-time position from Senior Administrative Services Analyst to County Service Area Manager. Reclassifies the incumbent from Community Services Analyst, resulting in a salary increase of 10%. The annual fiscal impact is \$10,219.

Office Support Specialist (G: General) Position: 2031 June 18, 2023	1.0	\$46,426 - \$56,430	Reclassifies the incumbent to the class of Office Support Specialist after a consultant review of the position. The incumbent is already working at this level in an out of class assignment, and the position is already authorized at this level. The annual fiscal impact is \$2,808.	
Procurement and Contract Services Officer (U: Supervisory) Position: 2161, PS-12790 June 18, 2023	2.0	\$84,074 - \$102,190	Establishes new class and salary range. Reallocates two (2) full-time positions (one (1) Regular; one (1) Limited-term) from Lead Buyer to Procurement and Contract Services Officer. Reclassifies the only incumbent, resulting in a salary increase of approximately 5.9%. The annual fiscal impact is \$29,286.

Emergency Medical Services Program Coordinator (U: Supervisory) Position: PS-14088 June 18, 2023	1.0	\$94,182 - \$114,483	Extends one (1) full-time limited-term position through 6/30/2024. The annual fiscal impact is \$0.
