



**ORDER FOR ELECTION TO FILL BOARD VACANCY
TRUSTEE AREA 5 VACANCY ON BOARD
RESOLUTION NO. 66-23**

WHEREAS, the resignation of Trustee Betsy Hyder on June 15, 2023, creates a vacancy in the seat representing Trustee Area 5 on the Board; and

WHEREAS, Education Code section 5091(a)(1) requires the Board to either appoint a provisional board member or order an election to fill the vacancy created by the resignation, within 60 days of the event creating the vacancy; and

WHEREAS, pursuant to Education Code section 5091(b), when an election is ordered, it shall be held on the next established election date provided pursuant to Section 1000 *et seq.* of the Elections Code, but not less than 130 days after the order of the election; and

WHEREAS, pursuant to Elections Code section 1000, the next established election date that is not less than 130 days after the order of election is November 7, 2023; and

WHEREAS, pursuant to Elections Code section 10002, the governing body of any district may by resolution request the Board of Supervisors of the county to permit the county elections official to render specified services to the district relating to the conduct of an election; and

WHEREAS, pursuant to Elections Code section 10400, whenever two or more elections of any public district, city, county or other political subdivision are called to be held on the same day, in the same territory, or in territory that is in part the same, they may be consolidated upon the order of the governing body or bodies or officer or officers calling the elections; and

WHEREAS, any election ordered to fill the vacancy should be consolidated with the election scheduled for November 7, 2023, pursuant to Education Code section 5342 and Elections Code section 10400 *et seq.*

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The Board hereby determines to order an election pursuant to Education Code section 5090(a)(1) to fill the Trustee Area 5 vacancy created by the resignation of Board member Betsy Hyder;
2. The Board requests the election to be consolidated with any and all elections also called to be held on November 7, 2023, insofar as said elections are to be held in the

same territory as Trustee Area 5 in the Davis Joint Unified School District or in territory that is in part the same as the territory of Trustee Area 5;

3. The Board hereby requests the Yolo County Board of Supervisors and Solano County Board of Supervisors to permit the County Registrar/County Clerk to provide any and all services necessary for conducting the election;

4. Pursuant to Education Code section 5322, the Board hereby orders an election to be held with the following specifications:

- a. The election shall be held on November 7, 2023;
- b. The purpose of the election shall be to elect a Board member to complete the term of office of Board member Betsy Hyder, Trustee Area 5;

5. The Board delegates to the Superintendent, or designee, all authority necessary and proper to accomplish the purposes of this Resolution.
