The Board of Supervisors hereby approves and authorizes the Chair to sign an amendment to the Authorized Salary and Position Resolution as follows:

Business Services Manager (U: Supervisory)	September 10, 2023	1.0	\$96,600- 113,755	Reallocates one (1) regular full-time position from Senior Administrative Services Analyst to Business Services Supervisor. Reclassifies the incumbent, resulting in a salary increase of approximately 11.3%. The annual fiscal impact is \$11,565.
Director of Strategic Operations (X2: Unrepresented- Professional)	September 10, 2023	1.0	\$152,401 - \$185,245	Establishes a new class and salary range. Reallocates one (1) full-time position from regular Manager of Governmental Relations to At-will Director of Strategic Operations. Reclassifies the incumbent, resulting in a salary increase of approximately 15.3% (which includes a current 10% differential that will end upon reclass). The annual fiscal impact is \$16,861.
Manager of Governmental Relations (X2: Unrepresented- Professional)	September 10, 2023	-1.0	\$125,944 - \$153,067	Abolishes class of Manager of Governmental Relations. There are no positions or incumbents assigned to this class. The annual fiscal impact is \$0.
Associate Management Analyst (C2: Confidential- Professional)	August 27, 2023	0.0	\$77,730 – \$94,481	Increases the salary range by approximately 12.54%. There are no positions or incumbents allocated at this level. The annual fiscal impact is \$8,662.
Management Analyst (C2: Confidential- Professional)	August 27, 2023	1.0	\$88,962 - \$108,133	Increases the salary range by approximately 12.50%. There is one (1) position and one (1) incumbent allocated at this level. The annual fiscal impact is \$9,880.
Senior Management Analyst (C2: Confidential- Professional)	August 27, 2023	2.0	\$108,597 - \$132,000	Increases the salary range by approximately 12.54%. There are two (2) positions and no incumbents allocated at this level. The annual fiscal impact is \$12,085.
Principal Management Analyst (C2: Confidential- Professional)	August 27, 2023	2.0	\$128,128 - \$155,740	Increases the salary range by approximately 12.54%. There are two (2) positions and no incumbents allocated at this level. The annual fiscal impact is \$14,275.

Solid Waste Attendant (G: General)  August 27, 2023	1.0	\$44,907 - \$54,600	Adds one (1) new limited-term (LT) full-time position to Integrated Waste Management. This position will expire August 27, 2025. The annual fiscal impact is \$54,600.
