**EIGHTH AMENDMENT
(BOS AGREEMENT NO. ____ - ____)**

This Eighth Amendment to Agreement No. 16-194 (“Eighth Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo, a political subdivision of the State of California (“County”), and California Forensic Medical Group, Inc., a corporation authorized to do business in the State of California (“Contractor”), jointly referred to as the “Parties” herein and who agree as stated below.

WHEREAS, on or about November 22, 2016, the Parties entered into Agreement No. 16-194 for the provision of comprehensive medical services to the detainees of the Yolo County Jail facilities (“Agreement”); and

WHEREAS, on or about September 24, 2019, the Parties amended the Agreement via the First Amendment; and

WHEREAS, on or about July 7, 2020, the Parties further amended the Agreement via the Second Amendment; and

WHEREAS, on or about December 15, 2020, the Parties further amended the Agreement via the Third Amendment; and

WHEREAS, on or about April 12, 2022, the Parties further amended the Agreement via the Fourth Amendment; and

WHEREAS, on or about June 29, 2022, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

WHEREAS, on or about December 6, 2022, the Parties further amended the Agreement via the Fifth Amendment; and

WHEREAS, on or about June 27, 2023, the Parties further amendment the Agreement via the Sixth Amendment; and

WHEREAS, on or about August 8, 2023, the Parties further amendment the Agreement via the Seventh Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Paragraph 3.A.** to add funding in the amount of \$598,704.90 for Fiscal Year (FY) 2023-24 for a new total contract maximum of \$24,324,868.26 utilizing \$579,899.28 in County General Funds (CGF) and \$18,805.62 in Medication Assisted Treatment (MAT) funding.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

1. **Paragraph 3.A.** of the Agreement is hereby amended to read as follows:

A. Subject to CPI escalation as set forth below, the maximum payment obligation to Contractor through **September 30, 2023**, shall be no greater than **TWENTY-FOUR MILLION THREE HUNDRED TWENTY-FOUR THOUSAND EIGHT HUNDRED SIXTY-EIGHT DOLLARS AND TWENTY-SIX CENTS (\$24,324,868.26)** specified as follows:
