### RECOMMENDED ACTION

### REASON FOR RECOMMENDED ACTION

### BACKGROUND

Dusan has over 10 years of experience in Human Resources within the manufacturing industry. Dusan has experience with preparing for organizational changes, training and development, succession planning, and talent management. As a member of the WIB, he is interested in sharing real world knowledge based on his experience and learning from other members on the WIB.

Appointment of Board members is based on Workforce Innovation Board (WIB) By-laws, supported by the Workforce Innovation and Opportunity Act. Appointment of Business applicant, Dusan Rodic is based on the Workforce Innovation Board By-law section 3.a) which states, "At least the majority (51%) of the WIB membership must be representatives of business in the local area." Additionally, the term of appointment is based on WIB By-laws which state in section 8. a) "The term of office for each WIB members is four (4) years from the date of appointment by the Board of Supervisors."

If ratified by the WIB and if approved by a majority vote, the application for appointment will be submitted to the Yolo County Board of Supervisors for approval by a majority vote.
