**EIGHTH AMENDMENT
(BOS AGREEMENT NO. ____ - ____)**

This Eighth Amendment to Agreement No. 19-16 (“Eighth Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo (“County”) and CommuniCare Health Centers (“Contractor”), jointly referred to as the “Parties” herein.

WHEREAS, on or about January 29, 2019, the Parties entered into Agreement No. 19-16 (“Agreement”); and

WHEREAS, on or about March 28, 2019, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

WHEREAS, on or about June 23, 2020, the Parties amended the Agreement via the First Amendment; and

WHEREAS, on or about August 17, 2021, the Parties further amended the Agreement via the Second Amendment; and

WHEREAS, on or about March 8, 2022, the Parties further amended the Agreement via the Third Amendment; and

WHEREAS, on or about March 15, 2022, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #2; and

WHEREAS, on or about April 6, 2022, the Parties further amended the Agreement via the Fourth Amendment; and

WHEREAS, on or about May 10, 2022, the Parties further amended the Agreement via the Fifth Amendment; and

WHEREAS, on or about August 9, 2022, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #3; and

WHEREAS, on or about January 3, 2023, the Parties further amended the Agreement via the Sixth Amendment; and

WHEREAS, on or about July 25, 2023, the Parties further amended the Agreement via the Seventh Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Section 1.** to extend the term of the Agreement through November 30, 2023; and
2. Revise **Section 4.** to add funding in the amount of \$40,253 for Fiscal Year (FY) 2023-24 for a new contract maximum of \$362,044; and
3. Revise **Paragraph C.1. of Exhibit C** to update rates for the months of October and November 2023.

NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. **Section 1.** of the Agreement is hereby amended to read as follows:

1. CONTRACTOR shall perform the following personal services: Urine Specimen Collection/Drug Toxicology Services for Child Welfare Services, as set forth with greater specificity in Exhibit A, from **July 1, 2018, and November 30, 2023**, unless sooner terminated as provided in this Agreement.

2. **Section 4.** of the Agreement is hereby amended to read as follows:

4. Subject to the satisfactory performance of the services required of Contractor pursuant to this Agreement, and to the terms and conditions set forth in this Agreement, and following Contractor’s submission of an appropriate claim, and such other documentation that the County may require, County shall pay Contractor according to the terms set forth in Exhibit C. Contractor agrees to accept the foregoing payments as full and complete payment for all services provided pursuant to this Agreement, irrespective of whether the cost of such services and related administrative expenses exceed such payments.

Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **November 30, 2023**, shall be no greater than **THREE HUNDRED SIXTY-TWO THOUSAND FORTY-FOUR DOLLARS (\$362,044)**, specified as follows:

3. **Paragraph C.1.** of **Exhibit C** is hereby amended to read as follows:

C. 1. Claims for payment shall be submitted to the County in an electronic format to HHSA.AccountsPayable@yolocounty.org. All claims shall be submitted with any required supporting documentation accompanying the claim. If a claim contains confidential client information, the claim and supporting documentation must be encrypted for transmission.

- 2. County shall pay Contractor at the rate specified below for services that have been provided in accordance with the provision of this Agreement.

Cost per Each Urine Specimen Collection	Rate effective dates
\$15.00/collection	July 1, 2018 through May 31, 2020
\$25.00/collection	June 1, 2020 through June 30, 2021
\$20.00/collection	July 1, 2021 through June 30, 2022
\$25.00/collection	July 1, 2022 through September 30, 2023
\$70.00/collection	October 1, 2023 through November 30, 2023

- 3. Except as specifically amended by this Eighth Amendment and any prior amendments, the Agreement shall remain in full force and effect according to its terms.
