RESOLUTION 2023 - 01**

Resolution Honoring Marcia Gibbs

WHEREAS, Marcia Gibbs was appointed to the Yolo County Planning Commission by the County Board of Supervisors on March 12, 2019, and attended her first Planning Commission meeting as an At-Large Commissioner on March 14, 2019, serving as Planning Commissioner for nearly four years, including serving as Vice-Chair in 2022; and

WHEREAS, since her appointment, Marcia attended over 30 Planning Commission meetings, including remote meetings during the COVID pandemic in 2020, 2021, and 2022; and

WHEREAS, during her term, Marcia showed a strong commitment to ensuring residential development projects provide an equitable distribution of housing types for all income levels, as well as the protection of agricultural resources; and

WHEREAS, during Marcia's term on the Planning Commission she participated in numerous significant County projects, including amendments in 2019 to extend the Development Agreement terms for the E. Parker, Story, and Orciouli residential subdivisions in Esparto and amendments to modify the Orciouli and Story Tentative Subdivision Maps in 2020 and 2021, respectively; approval of Tentative Parcel Maps in Esparto to subdivide an existing duplex and County Road 8 in Dunnigan to subdivide existing commercial serving uses in 2019; Farmland Security Zone (20-year Williamson Act) contracts and General Plan Amendment and Rezone recommendations to remediate the Old Bryte Landfill in 2019; EIR scoping workshop for the CLUO EIR in 2019, followed by numerous meetings to discuss and take final action and recommendation on the CLUO and CLUO EIR in 2020; recommendation on the Ban on Hemp Ordinance in 2020; launch of the comprehensive Zoning Code Update in 2020; mining permit amendments for various gravel mining operations 2020 and Interim Management Plan for Syar's idle operations in 2021; annual mining compliance reviews; 20-year update to the Cache Creek Area Plan (CCAP) in 2019 and 10-year permit review of the CCAP in 2021; approval of the Hay Kingdom and Wilbur Ellis Use Permits in 2021; 6th Cycle Housing Element update to the General Plan in 2021; review of the Gibson Solar Farm application for a very large solar energy generation system in 2021; several meetings to review, deliberate, and take final action and recommendation on the Teichert-Shifler Mining Permit and Reclamation Plan in 2021; recommendation on the Clark Pacific road abandonment of County Road 100B; approval of a cell tower in Clarksburg and deliberations on the Campbell Use Permit to legalize the permitting of ancillary dwellings in 2022; recommendations on updates to the Zoning Code involving urban lot splits and changes to the telecommunication and solar energy facilities ordinances, General Plan Amendment to update policies related to Environmental Justice and Climate Adaptation, and the historic landmark designation for the Barn at Utter Ranch in Clarksburg in 2022; 2022 approvals of the Old Sugar Mill Use Permit and Dwyer Tentative Parcel Map in Clarksburg; various presentations, including the Regional Housing Needs Allocation (RHNA) by SACOG, Cache Creek Resources Management Plan (CCRMP), and overview of agricultural preservation by Yolo Land Trust in 2019, the Cache Creek Parkway Plan and Drought and Groundwater Sustainability Plan, as well as Environmental Health and Valley Clean Energy (VCE) presentations in 2021;

WHEREAS, Marcia exhibited a reasonable and thoughtful approach when reviewing and making decisions on discretionary applications, zoning ordinances, and updates to the General Plan; and

NOW THEREFORE BE IT RESOLVED, that the Yolo County Planning Commission gives its heartfelt thanks to Marcia Gibbs for her dedication to the communities and residents of Yolo County; and

BE IT FURTHER RESOLVED, that the Yolo County Planning Commission extends its well wishes to Marcia Gibbs as she follows her passion for cycling and exploring new horizons.
