**SEVENTH AMENDMENT  
(BOS AGREEMENT NO. \_\_\_\_ - \_\_\_\_)**

This Seventh Amendment to Agreement No. 18-256 (“Seventh Amendment”) is made and entered into as of the last date signed below by and between the County of Yolo (“County”) and OLE Health, dba CommuniCare OLE (“Contractor”), referred to as the “Parties” herein.

**WHEREAS**, on or about November 20, 2018, the Parties entered into Agreement No. 18-256 (Agreement); and

**WHEREAS**, on or about March 6, 2019, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #1; and

**WHEREAS**, on or about June 26, 2020, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #2; and

**WHEREAS**, on or about July 21, 2020, the Parties amended the Agreement via the First Amendment; and

**WHEREAS**, on or about July 24, 2020, the Parties further amended the Agreement via the Second Amendment; and

**WHEREAS**, on or about January 12, 2021, the Parties further amended the Agreement via the Third Amendment; and

**WHEREAS**, on or about May 27, 2021, the County exercised its option to extend the Agreement under the same terms and conditions via Option Letter #3; and

**WHEREAS**, on or about August 24, 2021, the Parties further amended the Agreement via the Fourth Amendment; and

**WHEREAS**, on or about March 8, 2022, the Parties further amended the Agreement via the Fifth Amendment; and

**WHEREAS**, on or about June 6, 2023, the Parties further amended the Agreement via the Sixth Amendment; and

**WHEREAS**, on or about October 24, 2023, the County and CommuniCare Health Centers entered into a Consent to Assignment, effective October 1, 2023, with OLE Health dba CommuniCare OLE; and

**WHEREAS**, the Parties would now like to amend the Agreement, as previously amended, to:

1. Revise **Paragraph I.A.** to extend the term of the agreement through February 29, 2024; and
2. Revise **Paragraph II.B1.** to add funding in the amount of \$10,582 for Fiscal Year (FY) 2023-24 for a new contract maximum of \$988,022; and
3. Revise **Exhibit D** to update the budget for FY 2023-24.

**NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:**

**1. Paragraph I.A.** of the Agreement is hereby amended to read as follows:

**A.** The term of this Agreement shall be from **September 1, 2018 through February 29, 2024** unless

sooner terminated as provided in this Agreement.

2. Paragraph II.B.1. of the Agreement is hereby amended to read as follows:

**B.1.** Any other provision of this Agreement notwithstanding, the maximum payment obligation to Contractor through **February 29, 2024**, shall be no greater than **NINE HUNDRED EIGHTY-EIGHT THOUSAND TWENTY-TWO DOLLARS (\$988,022)** specified as follows:
