

**First Amendment to Agreement Creating the  
Yolo Animal Services Planning Agency Joint Powers Authority**

THIS FIRST AMENDMENT, by and between the County of Yolo and the Cities of Davis, Winters, West Sacramento, and Woodland (each individually a “Member” and referred to collectively as the “Members”), amends the Agreement Creating the Yolo Animal Services Planning Agency as a joint powers agency under California Government Code Section 6500 *et seq.* dated February 25, 2020. This First Amendment shall be effective upon the last date of execution of the Members.

**RECITALS**

**WHEREAS**, Government Code Sections 6500-6515, permitting two or more local public entities by agreement to jointly exercise any power common to them, authorizes the Members to enter into a Joint Exercise of Powers Agreement; and

**WHEREAS**, on or around February 25, 2020, the County of Yolo (“County”) and the Cities of Davis, Winters, and Woodland, entered into an Agreement (“JPA Agreement”) to create the Yolo Animal Services Planning Agency (“Agency”) as a joint powers agency; and

**WHEREAS**, Section 16 of the JPA Agreement authorizes amendment to the JPA Agreement by an affirmative vote of the governing bodies of 2/3 of the Members; and

**WHEREAS**, the Members wish to amend the JPA Agreement to add the City of West Sacramento as a member to the Agency;

**NOW, THEREFORE**, in consideration of the foregoing recitals, the parties hereby agree as follows:

**AGREEMENT**

1. The JPA Agreement is hereby amended to include the City of West Sacramento as a Member of the Agency. The City of West Sacramento shall have the same rights and responsibilities as any other Member under the JPA Agreement.
2. This Agreement may be executed in several counterparts, including electronic or facsimile counterparts, each of which is an original and all of which constitutes but one and the same instrument.
3. All other provisions of the JPA Agreement shall remain in full force and effect.
