

**RESOLUTION NO. 24-\_\_\_\_\_**

**RESOLUTION AUTHORIZING THE SUBMITTAL TO SACOG  
OF A CLAIM OF TRANSPORTATION NEED FOR AND  
REQUESTING SACOG'S APPROVAL OF THIS CLAIM**

**WHEREAS**, Section 99260 of the Public Utilities Code requires a local agency to file an estimated claim of transportation need for each fiscal year, including the fiscal year; and

**WHEREAS**, the Sacramento Area Council of Governments (SACOG) is the designated Transportation Planning Agency for the County of Yolo to receive and consider such claims for approval pursuant to rules and regulations adopted by the Secretary of the California Business, Transportation, and Housing Agency; and

**WHEREAS**, the attached Transportation Development Act (TDA) claim refers only to those transit projects which receive County Local Transportation Funding and State Transit Assistance; and

**WHEREAS**, the Cities of Woodland, Winters, Davis and West Sacramento are responsible for submitting their own TDA claims to SACOG; and

**WHEREAS**, SACOG conducted public hearings on unmet transit needs in the spring of 2016; and

**WHEREAS**, said hearings were conducted by SACOG in accordance with Section 99401.5(c) of the Public Utilities Code to solicit comments on the unmet transit needs that may exist within the unincorporated area of Yolo County and that might be reasonable to meet by establishing or contracting for new public transportation or specialized transportation services or by expanding existing services; and

**WHEREAS**, it is the intention of the Board that the projects identified in the attached claim will be included in the road and transit budgets when adopted by the County;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of Yolo as follows:

1. The Board hereby approves the attached Fiscal Year Transportation Development Act claim and authorizes and directs the County Director of Community Services to execute the attached FY 2023-2024 TDA claim for \$2,753,928 and to timely submit it to SACOG; and

2. The Board respectfully requests that SACOG approve the attached claim and take such other action as necessary to ensure payment of this claim to the County of Yolo is timely made.


