

**Yolo County Agreement No. 24-\_\_\_\_\_**

**THIRD AMENDMENT TO AGREEMENT NO. 14-25**

THIS Third Agreement to Agreement No. 14-25 (“Third Amendment”) is made and entered into as of this 27<sup>th</sup> day of February, 2024, by and between the County of Yolo, a political subdivision of the State of California (“County”), and American Medical Response West, d/b/a American Medical Response (“Contractor”) as stated below. County and Contractor are referred to herein collectively as “the Parties.”

**WHEREAS**, on or about March 1, 2013, the Parties entered into Agreement No. 14-25 (“Agreement”) for the provision of emergency ambulance services, advanced life support, and critical care transport by Contractor; and

**WHEREAS**, on or about February 26, 2019, the Parties entered into a First Amendment to the Agreement, which replaced the Agreement in its entirety with a term ending at 12:00 a.m. on February 28, 2024; and

**WHEREAS**, on or about June 8, 2021, the Parties further amended the Agreement No. 14-25 to revise Exhibit 1 - Ambulance Price Sheet via the Second Amendment; and

**WHEREAS**, the Parties are nearing completion of negotiations for a new agreement and want to amend the Agreement to extend its term briefly as provided below to allow the Parties to finalize the new agreement.

**NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:**

1. Paragraph **II.A** of the Agreement is hereby amended to read as follows:
  - A. Term of Agreement. This Agreement shall be effective as of 12:00 a.m. on February 1, 2014, and shall be in force and effect until **7:59 a.m. April 1, 2024**.
2. By signing this Third Amendment, the signatories warrant and represent that they executed this Third Amendment in their respective authorized capacity and that by signing this Third Amendment, the entity upon which the respective signed executed this Third Amendment.
3. Except as specifically amended hereinabove, the Agreement shall remain in full force and effect according to its terms.
