**SECOND AMENDMENT
(BOS AGREEMENT NO. _____)**

This Second Amendment to Agreement No. 23-161 (“Second Amendment”) is made and entered into as of the last date signed below, by and between the County of Yolo (“County”) and Victor Community Support Services (“Contractor”), jointly referred to as the “Parties” herein.

WHEREAS, on or about June 27, 2023, the Parties entered into Agreement No. 23-161 (“Agreement”); and

WHEREAS, on or about October 10, 2023, the Parties amended the Agreement via the First Amendment; and

WHEREAS, the Parties would now like to amend the Agreement, as previously amended, to revise **Paragraph III.D. of Article I** to add Medi-Cal billable funding in the amount of \$172,275 for Fiscal Year (FY) 2023-24 for a new contract maximum of \$915,775.

NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. Paragraph III.D. of Article I of the Agreement is hereby amended to read as follows:

D. The maximum financial obligation of County under this Agreement for the term of this Agreement shall not exceed **NINE HUNDRED FIFTEEN THOUSAND SEVEN HUNDRED SEVENTY-FIVE DOLLARS (\$915,775)**, as follows:

Fiscal Year 2023-24 July 1, 2023 through June 30, 2024
\$915,775

These amounts are not guaranteed but shall be paid only for services rendered and received in conformance with this Agreement.

2. Except as specifically amended by this Second Amendment and any prior amendments, the Agreement shall remain in full force and effect according to its terms.
